**Old Business:**

The ordinance of the Borough of Kenilworth adding Chapter 208 entitled "Tanning Facilities" was finalized by the Borough Attorney. He added the code number and the enhancements that were reviewed requiring liability insurance. This was the first reading at the town council meeting this week.

HO Gapas stated that the STD Agreement and the TB Agreements with the City of Elizabeth were not read into the minutes last month stating that we approved the contracts so they are on the agenda this evening to have them read into minutes that the contracts were approved. The sums remain unchanged.
