#### REPORT OF COMMITTEES

#### FINANCE DEPARTMENT

Councilwoman Karlovitch reported the public hearing on the Municipal Budget and final vote is scheduled for May 9, 2018 at 8PM. The budget represents a \$69.31 or a 2.7% increase for the average residential property taxpayer, assessed at 180,948.00 for the year. This does not include any increases from the school or County, of the \$69.31, \$44.61 or 2.5 tax point is from the Rahway Valley Sewerage Authority increase. We encourage residents to attend the public and final vote on May 9<sup>th</sup>, additionally a copy of the introduced budget will be made available on line on the Borough's website www.kenilworthborough.com Extra Duties Solutions will be commencing their work in the Borough by May 1<sup>st</sup>. Extra Duties Solutions provides online outside duty assignments for vendors looking to hire a police officer for private work. The program is more efficient and saves labor hours without any cost to the Borough. The Borough of Kenilworth is the only nearby municipality that processes payroll on a weekly basis. The Finance Office has researched changing from a weekly to biweekly payroll and based on their findings the change would free up labor hours to address some backlog of work without hiring additional personnel as well as implementing new initiatives such as updating to a new resident friendly website and implementing a new purchasing and budget policy manual. Such a change from 52 pays to 26 pays would save approximately \$5,300.00 for our budget and additionally if such a change takes place the Finance Department would roll out a new eservice program that will allow employees to see their financial information, pay stubs and W-2's on line, currently such information is retrieved manually from the Finance Department. Second Quarter taxes are due on May 1, 2018, the grace period to pay property taxes is Thursday, May 10, 2018 at 4:30PM. Taxes not paid by the 10<sup>th</sup> will accrue interest back to the first. Residents can pay taxes on line on our Boroughs website www.kenilworthborough.com or you can leave your payment in the Finance Office drop box 24 hours a day, 7 days a week.

#### **DEPARTMENT OF PUBLIC WORKS**

Councilman David reported that April 5<sup>th</sup> reported grass collection throughout the Borough and will continue every Thursday thru October. Last week it looked the brine was put out on the streets, he drove through town and wondered if we were expecting a blizzard but the brine was there because they had to empty the brine so they could clean the truck out...there was a minimal amount in the truck. There was an issue with 16<sup>th</sup> Street Park with the vines and trees and branches coming through the fence area by the backstop for the kids that were playing little league and the DPW cleaned it out. Rahway did an excellent job with the collection of the bulk waste pickup.
