Purpose:

The purpose of this Ordinance is to amend Chapter 91 Fees and Licenses whereby the Borough Council seeks to amend the Article II Police Reports and Services Fees for the Borough of Kenilworth.

BE IT HEREBY ORDAINED by the Council of the Borough of Kenilworth, County of Union, State of New Jersey as follows:

NOW THEREFORE, Chapter 91 Fees and Licenses, Article II "Police Reports and Services", Section 4 "Fees", item L is amended to read as follows:

91-4 L OFF-DI	JTY POLICE SERVICES
Service	Fee
Security	Hourly Rate in accordance with current collective bargaining agreement, plus \$10 per hour administrative fee
Construction /Traffic	Hourly Rate in accordance with current collective bargaining agreement, plus \$10 per hour administrative fee
Executive Protection	Hourly Rate in accordance with current collective bargaining agreement, plus \$10 per hour administrative fee

(1) In addition to all fees required for off-duty police services, a fee of \$15 per hour or any part thereof hall be due for the use of any police vehicle

Severability

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

Effective Date

This Ordinance shall take effect twenty (20) days after the first publication thereof after final passage as provided by law.
