PURPOSE OF REQUEST

The BOROUGH OF KENILWORTH is requesting proposals from qualified individuals and firms to provide **ENGINEERING SERVICES** of a specialized nature to the BOROUGH. Proposals will be evaluated in accordance with the criteria set forth in this RFP. One or more individuals/firms may be selected to provide services.

PERIOD OF CONTRACT

January 1, 2021 through December 31, 2021.

CONTRACT FORM

The successful proposer shall be required to execute the BOROUGH'S form contract, which includes the indemnification, insurance, termination and licensing provisions.

It is also agreed and understood that the acceptance of the final payment by Contractor shall be considered a release in full of all claims against the BOROUGH arising out of, or by reason of, the work done and materials furnished under this Contract.

Public Notice

Borough of Kenilworth has adopted the Fair and Open Process of the Pay-to-Play Law (N.J.S.A. 19:44A-20A, et seq.) in its request for proposals and awarding goods and services contracts with an annual value in excess of \$17,500.00. Proposals will be evaluated by the Governing Body of the Borough of Kenilworth on the basis of the most advantageous, price and other factors considered. The evaluation will consider:

- a. Experience and reputation in the field;
- b. Knowledge of the Borough and the subject matter to be addressed under the contract.
- c. Availability to accommodate any required meetings of the Borough;
- d. Compensation proposal;
- e. Other factors if demonstrated to be in the best interest of the Borough.

In addition to the above criteria, the Borough may consider the following criteria, where applicable, in order to evaluate the proposal.

- a. Assurances of performance;
- b. Vendor's financial ability and strength to meet its obligations;
- c. How the costs compare to other proposals;
- d. If available, are suitable warranties and guarantees available.

To this end the Borough is seeking proposals for the following;

Engineering Services

NATURE/SCOPE OF SERVICES:

The Borough of Kenilworth is requesting qualifications for Engineering Services. The engineering firm may have a close working relationship with any of the following offices: Office of the Borough Clerk, the Department of Public Works, the Department of Recreation and Parks and the Office of the Borough Attorney.

The Borough of Kenilworth utilizes a number of services to be provided by outside consulting engineering Firms. Contracts are generally awarded on a project by project basis. The Borough is seeking proposals from firms to be prequalified on a fair and open basis to perform some or all of the following types of work.

- i) Site land use and environmental engineering;
- ii) Facility, infrastructure and project design, construction, and operation.

Including: roadway improvements, culverts, traffic studies, signalized and unsignalized intersection improvements, parks, drainage improvements, flood control improvements,

landscape architecture and planning, surveying/GIS/mapping, and environmental/cultural investigation, evaluation and remediation projects.

- iii) Building systems evaluations, including but not limited to:
 - (a) conducting on site investigations of heating, ventilation, air conditioning, electrical, plumbing, fire protection and control systems and making recommendations for any necessary modifications;
 - (b) assessing building systems for functionality, energy efficiency, environmental compliance, comfort and air quality;
 - (c) performing safety and code audits;
- iv) Mechanical design services including but not limited to:
Preparation of plans, specifications, conceptual design, cost estimates and project manuals for various types of building mechanical systems;
- v) Prepare and submit permit applications, General Grant Applications, correspondence, and the like to the New Jersey Department of Environmental Protection and any other applicable state or federal regulatory agency as well as any other private entity, as required;
- vi) Provide Construction Administration/Inspection Services for all types of Civil Engineering Infrastructure projects including; roadway improvements, flood control and drainage projects, culverts, signalized intersection improvements, parks, and environmental remediation projects.
- vii) Provide Material Testing and Geotechnical Services including the field collection, field compaction testing and laboratory reporting for: concrete, bituminous concrete, steel as well as soil and other types of construction materials as may be required.
- viii) Environmental Testing and Monitoring.

Please provide qualifications for any or all of the areas listed above that your firm is interested in being considered for.

STANDARD REQUIREMENTS OF TECHNICAL PROPOSAL - Proposers should submit a technical proposal which contains the following:

- A.** Number of copies required: one (1) original (signed in ink), one (1) copy and one (1) digital copy (*size should not exceed 10KB*) of each proposal shall be submitted.
- B.** The name of the proposer, the principal place of business and, if different, the place where the services will be provided;
- C.** Outline the specific type services to be provided as noted in Scope of Services above
- D.** Proposer must have a minimum of fifteen (10) years experience in providing engineering type services and a minimum of ten (5) years servicing municipalities and other local governmental entities;
- E.** The education, qualifications, experience, and training of all persons who would be assigned to provide services along with their names and titles; The proposer **MUST** possess a valid P.E. license in the State of New Jersey as appropriate with the type

of services being offered, and any other licenses or certificates necessary for the type of work proposed;

- F.** A listing of all other engagements where services of the types being proposed were provided in the past five (5) years. This should include other municipal governments and other levels of government. Contact information for the recipients of the similar services must be provided. The Borough may obtain references from any of the parties listed;

A description of all other areas of **ENGINEERING SERVICES** of the proposer, with emphasis on a description of those services of interest to a Municipal client.

- G.** A Statement that neither the firm nor any individuals assigned to this engagement are suspended, or otherwise prohibited from professional practice by any federal, state, or local agency;
- H.** An Affirmative Action Statement (copy of form attached);
- I.** A completed Non-Collusion Affidavit (copy of form attached);
- J.** A completed Owner Disclosure Information form (copy of form attached);
- K.** A statement that the proposer will comply with the General Terms and Conditions required by the Borough and enter into the Borough's standard Professional Services Contract;
- L.** A copy of the proposer's Business Registration Statement; and
- M.** A completed Disclosure Statement.

COST PROPOSAL - Proposers should submit a cost proposal which would include any proposed retainer, the services to be provided for the retainer, if services will be provided at a flat rate, if all or any services will be billed through hourly rates and what are the established rate(s). The Borough does not provide payment for or reimbursement for travel expenses.

PROPOSAL EVALUATION – The Borough will select the most advantageous proposals based on all of the evaluation factors set forth at the end of this RFP. The Borough will make the award(s) that is in the best interest of the Borough.

Each proposal must satisfy the objectives and requirements detailed in this RFP. The successful proposer shall be determined by an evaluation of the total content of the proposal submitted. The Borough reserves the right to:

- a. Not select any of the proposals;
- b. Select only portions of a particular proposer's proposal for further consideration; (However, proposers may specify portions of the proposal that they consider "bundled".)

- c. Award a contract for the requested services at any time within 60 days of the selection of the most advantageous proposal; Every proposal should be valid through this time period.

The Borough shall not be obligated to explain the results of the evaluation process to any proposer.

The Borough may require proposers to demonstrate any services described in their proposal prior to award.

PROPOSAL LIMITATIONS – This RFP is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on the Borough by issuance of this RFP. The Borough reserves the right at the Borough’s sole discretion to refuse any proposal submitted.

USE OF INFORMATION - Any specifications, drawings, sketches, models, samples, data, computer programs, documentation, technical or business information and the like (“Information”) furnished or disclosed by the Borough to the proposer in connection with this RFP shall remain the property of the Borough. When in tangible form, all copies of such information shall be returned to the Borough upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the Borough or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFP, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

GENERAL TERMS AND CONDITIONS –

- A. The Borough reserves the right to reject any or all proposals, if necessary, or to waive any informalities in the proposals, and, unless otherwise specified by the proposer, to accept any item, items or services in the proposals should it be deemed in the best interest of the Borough to do so.
- B. In case of failure by the successful proposer, the Borough of Kenilworth may procure the articles or services from other sources, deduct the cost of the replacement from money due to the proposer under the contract and hold the proposer responsible for any excess cost occasioned thereby.
- C. The proposer shall maintain sufficient insurance to protect against all claims under Workmen's Compensation, General, Professional and Automobile Liability.
- D. Each proposal must be signed by the person authorized to do so.
- E. The contract shall be in effect through December 31, 2021 unless otherwise stated.

- F.** Proposals may be hand delivered or mailed consistent with the provisions of the legal notice to proposers. In the case of mailed proposals, the Borough assumes no responsibility for proposals received after the designated date and time and will return late proposals unopened. Proposals will not be accepted by facsimile or e-mail. Proposals shall be in a sealed envelope, marked ***“Proposal for Engineering Services” To be considered, proposals shall be delivered to or received by the Administrator by no later than 3:00 pm on October 28, 2020***
- G.** Proposers are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. See attached exhibit A.
- H.** By submission of the proposal, the proposer certifies that the service to be furnished will not infringe upon any valid patent, trademark or copyright and the successful proposer shall, at its expense, defend any and all actions or suits charging such infringement, and will save the Borough harmless in any case of any such infringement.
- I.** No proposer shall influence, or attempt to influence, or cause to be influenced, any Borough officer or employee to use his/her official capacity in any manner which might tend to impair the objectivity or independence of judgment of said officer or employee.
- J.** No proposer shall cause or influence, or attempt to cause or influence, any Borough officer or employee to use his/her official capacity to secure unwarranted privileges or advantages for the proposer or any other person.
- K.** Should any difference arise between the contracting parties as to the meaning or intent of these instructions or specifications, the Borough Counsel’s decision shall be final and conclusive.
- L.** The Borough of Kenilworth shall not be responsible for any expenditure of monies or other expenses incurred by the proposer in making its proposal.
- M.** The checklist, affidavits, notices and the like presented at the end of this Request for Proposals are a part of this Request for Proposals and shall be completed and submitted as part of this proposal.
